Background and significance:

The spread of various types of narcotic drugs has forced world countries to adopt a specialized approach in dealing with the treatment of addicts. On this basis, measures have been taken to prepare and formulate treatment and educational protocols.

Basically, experiences and information with regard to successful lessons have been shared that can be of great importance. Holding technical training courses is one of the effective methods for attaining this goal.

Based on its commitments towards CICA as a multilateral and regional body, the Islamic Republic of Iran has put on its agenda the holding of technical meetings covering various aspects of drug control. In line with this, the first training course on treatment and reduction of harms caused by addiction to narcotic drugs was successfully held in virtual manner for the member states on August 4, 2021.
